

Regulated Price Plan Declaration Form for Multi-Unit Residential Premises

The Regulated Price Plan (RPP) is available to businesses in a Class B Global Adjustment status with electricity consumption of 250,000 kilowatt hours or less annually. Multi-unit residential premise customers who own, or manage, a building that has multiple residences, but only one meter, may declare this information to qualify for the RPP Tiered thresholds for each residential unit.
